I applied for a \$12,000 grant to Lake County Stormwater Commission for consulting help with the lake management plan. Planning to meet with the Mundelein Park District to discuss consultants they have used in past for their lake management planning. Also planning to meet with the Lake County Stormwater Commission to discuss our lake inlets. Overall looking to leverage experience and input from these parties which have also dealt with lake

These statistics provide the LLPOA Lakes Management Committee with data to inform future budget, fish stocking, and lake treatment guidelines. Please do not remove, move, or damage these buoys.

Dam, Path & Entrances

There is nothing new to report this month. Participating in budgeting for the 2017 fiscal year.

Boat Committee

Phil Kweton presented.

Overall sticker compliance continues to improve slightly. We will continue to monitor sticker compliance for storage and lake usage per the boat policy. We are already thinking ahead to next year and topics we need to tackle including compliance for boats on private land and storage limits at our beaches. The committee meets the first Wednesday of every month for anyone that would like to join.

North Beach

Mickey Emde presented.

The last phase of the channel erosion work was completed this month. It should reduce the amount of sediment flowing into the lake during big storms. We are looking forward to getting the last few boats up in storage before the weather changes. If your boat is still on the beach, please store it on the racks as there is now room for every boat. It was a good season for all our residents at North Beach. Remember pooch paddle is available on Monday, Wednesday and Friday evenings. South Beach

Rob Scharf presented.

Denise had the water shut off for the winter and also put the volleyball net away for the winter.

Denise painted the large Loch Lomond sign in front of the beach. It looks very nice.

Tony Baade installed a lake water level gauge on the fishing pier.

We put up an additional 25 feet of goose fence between the east side of the swimming pier and the planting buffer strip.

The road construction crew is currently working on the road in front of the beach. Please be very careful when approaching that area.

Old Business

In coordination with the lake management plan, the north and south beach directors would like to work on a multiyear plan for maintenance and improvements at our beaches.

Rob Scharf suggested the board put forth a recommendation to the Village of Mundelein regarding more stop signs in Loch Lomond to reduce traffic speeds. After some discussion, next steps are for Rob to work with the board and input from residents to determine intersections of concern. Then a comprehensive recommendation can be taken to the Village of Mundelein Board meeting at a later date. In the meantime, individual residents can go to the Village of Mundelein board meetings anytime to raise this

concern. Meeting dates are listed at the end of our newsletter. Residents are invited to the November 14th LLPOA meeting to provide input on where additional stop signs are needed.
