Electric Power Watercraft: Loch Lomond Lake

The beaches, parks, picnic areas and more are "exclusively" for Paid-up Member Residents in "good standing". LLPOA members who are in good standing may invite guests to share in the amenities of our community, however, their guest's actions and behavior are the total responsibility of said member Resident. All persons, with respect to the use of the lake while fishing, boating, swimming, and all other general lake/water usage, follows the rules and regulations of the State of Illinois, County of Lake and Village of Mundelein and the LLPOA. These expectations are clear and understandable to maintain "good standing" status.

We are a small 75acre shallow lake with an average depth of 6 feet. The new "party style" pontoon boat is limited to 18 feet in length and not any larger. There is only so much space in the lake for all our residents. Every year more pontoons are added to the lake. Therefore, we must require this size limit of 18'. The new style pontoon watercraft of this size and design is not permitted to be stored at our beach storage areas! We simply, cannot accommodate the size and design of this pontoon watercraft. Only one large pontoon boat maybe stored or mored on an individuals property or pier to help keep the visual aesthetics of our lake and our neighbors.

No internal combustion devices (gas powered motors) are permitted for any use on the lake by Residents! This is strictly prohibited by the Loch Lomond Property Owners Association and includes all watercraft, ATV and toy model boats. *Additionally, and regardless of power type,* no personal watercraft designed for the purpose of Wave runner, Jet ski, Surf jet are strictly prohibited.

The list below describes the requirements for allowing lake traffic to include not only human and sail power but electric power on the lake <u>exclusively</u> for "Paid-up Resident Members in good standing".

- 1 You must be <u>a Resident of</u> the Loch Lomond Community/subdivision.
- 2 As Resident, you <u>must be a paid-up member in "good standing"</u> in the <u>Loch Lomond Property</u> Owners Association.
- 3 Residents requesting a permit for electric power <u>must own the water craft</u> used for that purpose.
- 4 Upon request, it is expected boat owners will be able to show proof of ownership of the water craft.
- 5 As required, all watercraft used on the lake <u>must have the most current annual stickers for lake use and/or storage at LLPOA facilities</u>. Stickers must be <u>permanently displayed</u>.
- 6 Permit requests for electric power watercraft <u>will only be considered when Residents are compliant with numbers 1-5above.</u>
- 7 <u>Permits for electric power will be considered</u>, o<u>nly when the thrust is 70 lbs. or less for one or two battery operation and no more than 3hp for four battery systems, the maximum boat <u>size</u></u>

- does not exceed 18 feet, and a maximum 24 volt; 4 battery system or less is used for power. 8 Upon request, residents applying for electric power WILL BE REQUIRED to show the "thrust power" of the device being used along with the battery system.
- 9 Electric power use shall not create any greater wake than human powered watercraft. This means; it shall be operated at a "NO WAKE" speed at all times.
- 10 Electric propelled power devices will not be stored at the LLPOA beaches on the lake.
- 11 <u>Batteries will not be stored at the LLPOA beaches</u> on the lake.
- 12 <u>Residents are accountable and responsible for storage</u>, <u>security</u>, <u>use and/or Misuse</u>, (operator error) of <u>electrified watercraft</u>.
- 13 Electric power watercraft use <u>must follow all rules and expectations</u> of State, County, Village and the LLPOA.
- 14 <u>Residents must follow "Safety Standards and Registration Standards"</u> set forth by the State of Illinois: IDNR for all watercraft.
- 15 "Permits" for electric power (flag and sticker) will have a one time fee of \$10, and must be permanently displayed on the designated watercraft.
- 16 Trailered boats at LLPOA launch sites <u>must be inspected before and after use</u> to remove invasive plants and other species from boat, propellers and the electric power device. Under no circumstances can any water from any boat entering Loch Lomond Lake be pumped, bailed, or dumped from the boat, live wells, bait wells, minnow buckets etc. into our lake.
- 17 Watercraft launched at Loch Lomond lake <u>must have all current LLPOA stickers</u> like lake use registration, and/or storage, or electric power device <u>permanently fixed prior</u> to launch.
- 18 Any towing of inflatable devices, boats, SUP boards, wake boards, knee boards, skiers designed to be ridden on the water is prohibited except for emergency cases only.
- 19 <u>Persons between 12 and 18 are required by Illinois Law to have a "Boating Education Certificate" and be under direct supervision of a parent, guardian, or an adult 18 years of age designated by the parent or guardian. **It is the law!**</u>
- 20 Resident members paid-up <u>but not abiding by the requirements of the LLPOA and the related Agencies</u> as outlined above, may lose their "good standing" in the Association and "loss
