



LOCH LOMOND PROPERTY OWNERS ASSOCIATION RULES FOR USE OF THE LAKE AND BEACHES

A great deal of time and money is invested in the Association properties for our enjoyment. These rules are established to maintain safety, assure proper use of our lake facilities, and prevent vandalism and trespassing. Do your share by obeying and helping enforce these rules, giving your time to help us maintain the areas, and paying your fair share for the use of these properties and equipment. The rules apply year round.

General (these rules apply to all categories of activity on the lake):

1. ***Each member is responsible for their own conduct, and the conduct of their guests.***
2. No illegal drugs are allowed on Loch Lomond property.
3. State and local ordinances shall be enforced on Loch Lomond property. Trespassers will be prosecuted under Village Ordinances.
4. No unauthorized persons are allowed on the dam or spillway areas along Route 45 or on the North Beach dam or silt pond.
5. Punishment for vandalism will be decided by the Association Board and the Mundelein Police.
6. Disobedience of the rules, or abuse of the privilege of using the beach will be acted upon as follows:
 - a. 1st Offense - 1 week suspension of beach privileges
 - b. 2nd Offense - 2 week suspension of beach privileges
 - c. 3rd Offense - Association Board action

Membership Identification

One keycard is issued per address to enter locked gates. Sellers should relinquish their keycard to new owners. Replacement key cards are \$20.

Beach Areas

1. Members are allowed a reasonable number of guests when using the beach. All parties at the beach TOTALING more than fifteen people must be approved through the Administrator. Forms are available on the Loch Lomond website.
2. No organizational parties (i.e., sports team, church groups, company outings, etc.) are allowed due to insurance restrictions.
3. Loch Lomond residents not LLPOA Members in good standing (fully paid accounts) are not allowed to be guests.

4. Reasonable and proper conduct is expected at the beaches.
5. No children under 12 years of age will be admitted unless accompanied by a parent, other responsible adult, or other family member over 12 years of age.
6. Persons under the age of 16 must be accompanied by a responsible person 16 years of age or older, unless a lifeguard is present.
7. Beach areas are closed to children under 18 years of age after 9 PM unless accompanied by parents.
8. Beach areas are closed to all use from 11 PM to 5 AM year round. Village police are authorized to arrest trespassers.
9. Vehicles or boat trailers must not be parked on the beach area or in front of gates. Large gates are posted for emergency vehicle use.
10. Absolutely no glass beverage containers are allowed in the swimming area, including sand, pier, and rafts.
11. No alcoholic beverages will be allowed in the actual swimming area. This includes the swimming pier, rafts, and designated swimming area.
12. Smoking Policy – Smoking at the South Beach is only allowed on the East end of the beach in between the dumpster fence and basketball court. No smoking is allowed in any other part of the beach. Please make sure all spent smoking materials are placed in a garbage container, all flames extinguished, and ashes cool. Use water if necessary.
13. No open fires are allowed in the picnic areas. BBQ grills are provided. Members' portable grills may also be used.
14. No pets are allowed inside the fenced area at South beaches except leashed service animals on the far east side of the beach, on the grass only. Dogs are allowed at North beach anytime.
15. No hard objects may be thrown, only soft balls or those appropriate and not harmful to others on the beach at the time. No stone throwing in the beach or creek areas.
16. Admittance to beaches is through gates only. Climbing fences will be considered trespassing.
17. Proper attire is required when swimming.
18. Park bicycles in racks provided when possible.
19. No water balloons or fireworks are allowed on LLPOA property at any time.
20. AT NO TIME ARE FIREARMS PERMITTED ON LLPOA PROPERTY.
21. Inflatables (bounce houses, obstacle courses, etc.) are not permitted on LLPOA property.

Swimming

1. Every swimmer should be familiar with the Illinois Department of Public Rules as they apply to the usage of our swimming beach. Those mandated health-based IDPH rules are posted at the beach on blue and white sign(s) and are for everyone's safety.
2. No running or horseplay on rafts or piers.
3. No diving off piers.
4. No Playing under piers.
5. No swimming under rafts.

6. No inflatable toys or inner tubes beyond the rafts.
7. Non-swimmers may not utilize any flotation device to go beyond the pier.

Boating

1. The lake is restricted to sailboats and sailboards, canoes, rowboats, paddle boats and similar water craft.
2. All boats must have a current LLPOA boat sticker
3. Electric motors are permitted and follow a strict procedure and permit regulations for use in the lake (see boating rules)
4. No beverages in glass containers are allowed in boats.
5. Iceboats that are sail operated may be used when the lake is frozen.
6. Snowmobiles or motorized ATV's are not allowed on the frozen lake.
7. Members in good standing wishing to store their boat(s) at either beach must pay an annual storage fee of \$35.00.
8. Storage is limited. Requests are fulfilled on a first come, first served basis as storage space allows. Owners can indicate a beach preference, North or South, when requesting a storage spot.

Fishing

1. All fishermen, including ice fishermen, must be Members in good standing or guests of Members in good standing. Guests **MUST** be accompanied by Members.
2. No winter structures will be left overnight on the lake ice.
3. Absolutely no fishing allowed ANY TIME in the swimming area or from the swimming pier.
4. Regulations regarding size and quantity limits for game fish are posted at the beach entrances.
5. No cleaning of fish is allowed in the beach swimming area.
6. The Association stocks the lake with game fish for the benefit of Members and their guests. Please help everyone to enjoy better fishing by observing the following rules:
LLPOA strongly encourages catch and release of all Northern Pike and Large Mouth Bass over 14 inches
7. Creel limits (the number of fish of a given species you can keep from one day's fishing):
 - a. Bass – the creel limit is 6 per day per person with no minimum length.
 - b. Bluegill, Crappie and Catfish – no creel or size limit.
 - c. Northern Pike – creel limit is 3 per day per person with a minimum length of 24 inches.
